- The applicant must be a resident of Clark County. The recipient of this **scholarship** must attend as a full-time student at any college or university.
- Students must be graduating seniors (2024).
- The applicant shall have a GPA of 2.5 or better as of December 2023.

APPLICATION PROCESS (Complete steps #1-5 and email to ccswd1@gmail.com, incomplete applications will not be accepted.)

- 1. Complete the attached information form and waiver.
- 2. Obtain one recommendation letter from a teacher.
- 3. Write a letter (one page maximum) describing goal of video and explaining why recycling is important to you.
- 4. Submit a maximum of 35 second video, MP4 format promoting the benefits of recycling.
- 5. Submit a copy of transcript.
